ROOM CATEGORIES & DETAILS

Aiming to offer modernity and simplicity together, all of our rooms have ceramic floors, balconies, bathroom with shower cabin, hair dryer, direct dial telephone, minibar*, National and International Satellite TV, rental safe**, central air conditioning (at certain hours) and sofa bed.

Standart Room:

We have a total of 90 rooms ranging from 22m2 to 25m2 in width. It consists of a bedroom with a choice of two separate single beds or one large bed, and a bathroom with shower. The room can accommodate up to 3 people.

Disabled Room:

We have 1 Disabled room in the Standard room category specially prepared for our guests.

Family Room (Duplex):

A total of 6 Family Rooms are available. It is in the category of a double-storey room with stairs and has one large bed in one room and two separate single beds in the other room. There is a bathroom with a shower/WC. The average room size is between 55m2 -60m2. Unit sales are calculated on at least 3 people. The maximum occupancy capacity is 4 people.

Suite:

16 Suite rooms, which are evaluated in the Suite / Family room category, consist of 1 bedroom (1 large bed + 1 sofa bed) and 1 bathroom / wc with shower. Our Suite Rooms are 45m2 - 50m2 in size. Unit sales are calculated on at least 3 people. The maximum occupancy capacity is 4 people..

WIRELESS / INTERNET

Rooms, Lobby, meeting rooms and all public areas

ISSUES THAT OUR GUESTS SHOULD PAY ATTENTION TO

- In accordance with the legislation numbered 4207 smoking is prohibited in indoor areas and as well smoke free outdoor units..
- In accordance with the legislation numbered 1774 all guest must present valid ID/passport upon registration.
- In accordance with the legislation numbered 5651 hotel internet network is under surveillance with encrypted file servers
- Number of equipment promised to be given to the guests free of charge and / or with deposit is available in our hotel, it can be allocated in line with the existing stocks and with reservation.
- In all restaurants and bars, drinks within the concept are served with a glass .Not served by bottle.
- Drinks are served only over 18 years old guest and imported drinks served by permission by Ministry of Agriculture and imported by Customs Directorate with official regulation.
- The hours and service locations of outdoor units and entertainment programs may change or be canceled according to weather conditions. The hotel management is authorized to make changes, cancellations and changes to the places within the time frame covering the property information and importance.
- Hotel information must be approved by the hotel management before its use in printed products (catalogs, magazines, advertisements, etc). All kinds of written documents and information submitted without approval belong to the distributing institution and the facility is not responsible for any errors that may arise. In this context, the written information in the printed documents is evaluated by the printing institution according to the changes made..
- Daily visitors from outside the hotel are accepted for paid until 09.00 19.00. Day visitors after 19:00 are not allowed in the property. (The application is charged as half day and full day, this application is at the decision of the hotel management)
- Towel card system is applied for beach towels. If the towel cards or towels are not returned on the day of departure, the amount written on the back of the towel card will be charged to the guests as much as the amount lost.
- In case of damage to the general areas of the hotel and/or the materials in the rooms by the guests, the responsibility belongs to the guests.
- Taking foods from restaurants and other food and beverage units to guest rooms with individual efforts is not allowed because it poses a risk to food and hygiene safety..
- The use of hookah in rooms and public areas with individual facilities is dangerous and prohibited.
- Wireless portable speakers are not allowed to be used in the property, in the rooms and in the common areas of the guests due to the complaints obtained..
- Main restaurant dress code is available. Slippers shorts t-shirts are accepted in the morning and noon, and the smart-casual rule
 defined by shoes, pants and shirts and derivative clothing is applied in the evening. Use of wet swimsuit seating areas indoors is
 restricted.
- Advertisements arising from services that are within our concept but cannot be provided due to the Pandemic are not accepted.
